DATES AND VENUES OF THE 91ST, 92ND AND 93RD MEETINGS OF THE EXECUTIVE COMMITTEE

91st meeting

1. At its 87th meeting, the Executive Committee decided to hold its 91st meeting from 28 November to 2 December 2022, in Montreal, Canada, at the International Civil Aviation Organization (ICAO) (decision 87/60(c)). After a member's request, the Secretariat would also like to present for the consideration of the Executive Committee an alternative option for holding the 91st meeting of the Executive Committee from 5 to 9 December 2022, in Montreal, Canada (venue has been identified).

92nd and 93rd meetings

2. The approved 2023 budget² made provision for two meetings of the Executive Committee in Montreal; accordingly, the Secretariat has made tentative bookings at ICAO as follows:

92nd meeting

Option 1: 29 May to 2 June 2023

Option 2: 12 to 16 June 2023

93rd meeting

Option 1: 9 to 13 October 2023

Option 2: 16 to 20 October 2023 (back-to-back with the 35th Meeting of the Parties to the

Montreal Protocol at a venue to be determined)

3. Taking into account the year 2023 is the Fund replenishment year, the Secretariat has proposed option 2 for the 93rd meeting in case the Executive Committee would like to hold its meeting back-to-back with that of the Parties.

Other meetings in 2023

- 4. The Executive Committee may wish to note the dates for the following meetings taking place in 2023 with venues yet to be determined:
 - 1 July 2023: 70th meeting of the Implementation Committee under the Non-Compliance Procedure for the Montreal Protocol.
 - 3 to 7 July 2023: 45th Open-ended Working Group of the Parties to the Montreal Protocol.
 - 21 October 2023: 71st meeting of the Implementation Committee under the Non-Compliance Procedure for the Montreal Protocol.
 - 23 to 27 October 2023: 35th Meeting of the Parties to the Montreal Protocol.

Recommendation

- 5. The Executive Committee may wish:
 - (a) To consider to hold its 91st meeting, in Montreal, Canada, from 5 to 9 December 2022 instead of 28 November to 2 December 2022 pursuant to decision 87/60(c);
 - (b) To hold its 92nd meeting:
 - (i) From 22 to 26 May 2023, in Montreal, Canada, at the International Civil Aviation Organization (ICAO); or
 - (ii) From 12 to 16 June 2023, in Montreal, Canada, at ICAO.
 - (c) To hold its 93rd meeting:
 - (i) From 9 to 13 October 2023, in Montreal, Canada, at ICAO; or
 - (ii) From 16 to 20 October 2023 (back-to-back with the 35th Meeting of the Parties to the Montreal Protocol at a venue to be determined).
