REPORT ON BALANCES AND AVAILABILITY OF RESOURCES

Introduction

1. This document presents a summary of financial adjustments indicated by the bilateral (BAs) and implementing agencies (IAs) as agreed by the Secretariat. It includes statistical data² from all projects with balances that have been held for over 12 months following completion of the project, as required by decisions 28/7 and 56/2(c). It addresses balances to be returned against projects as a follow-up to relevant decisions (referred to as "by-decision" projects in this document). The document also follows up on the Office of Internal Oversight Services (OIOS) recommendation on the financial closure of projects (decision 88/1(d)). It further indicates the level of resources available to the Executive Committee in cash as recorded in the status of contributions and disbursements document,³ as required by decision 41/92(b), and presents a recommendation. The amounts that are held by IAs and BAs for completed projects and for by-decision projects are included in Annex I and Annex II, respectively. Annex III presents the funds returned by IAs and BAs from completed, by-decision, and additional voluntary contributions projects.

Funds to be returned to the 90th meeting

2. The total funds to be returned by IAs amount to US \$3,360,846 as shown in Table 1.

Funds withheld by IAs and BAs

Balances held by BAs

4. Japan withheld a balance of one project completed in 2020 amounting to US \$50,059 including agency support costs.

Follow up to decision 88/1(d)

At the 88th meeting, in the context of the audit of the Multilateral Fund by the OIOS, the Executive 5. Committee requested the Fund Secretariat, the Treasurer, the BAs and IAs to complete implementation of OIOS recommendation 5 to implement the elements of the action plan to address the delays in financial closure of projects beyond the twelve-month limit stipulated by the Executive Committee, and to include information in that regard in relevant meeting documents (decision 88/1(d)). In addressing this OIOS recommendation, on 12 November 2021, the Fund Secretariat sent an official communication to the BAs and IAs reminding them to rigorously implement all the elements of the action plan in place since the 28th meeting and to adhere to all subsequent decisions, and to financially close all projects no later than the twelve-month limit stipulated by the Executive Committee. This recommendation was also addressed by the Secretariat at the Inter-agency Coordination Meeting, held on 31 March to 1 April 2022. The Secretariat also sent to the IAs for their action a list of completed projects with balances in 2020 and prior. The Secretariat has also reminded the agencies of the need to inform the Secretariat on a continuous basis if there are any anticipated issues with the financial closure so that early action can be taken. The statistics shared with OIOS shows that UNDP has financially closed all competed projects in 2018 and 2019 and committed to close 10 projects that are multi-year agreement tranches, UNEP has achieved a 96 per cent compliance rate with the audit recommendation and committed to close additional four projects and UNIDO had closed 38 projects and committed to close nine more projects while the World Bank has no balances withheld on completed projects. Subsequently, the OIOS agreed to close the observation on delays in financial closure of projects beyond the twelve-month limit stipulated by the Executive Committee.

Availability of resources

6. The status of contributions and disbursements document indicates an available balance of US \$424,470,206 as of 5 May 2022. The total balance returned by IAs, to the 90th meeting amounts to US \$3,360,846. Therefore, the total level of resources available for approvals at the 90th meeting, is US \$427,831,052.

Secretariat's comments

- 7. The Secretariat reminded BAs and IAs that balances of by-decisions projects and projects completed one year ago and more, should be returned to the Multilateral Fund as soon as possible.
- 8. Considering that the total level of funding for projects and activities submitted to the 90th meeting as of 2 June 2022 is US \$18,550,280, there are sufficient resources available for approvals at the 90th meeting.

Recommendation

- 9. The Executive Committee may wish:
 - (a) To note:
 - (i) The report on balances and availability of resources contained in document UNEP/OzL.Pro/ExCom/90/4;
 - (ii) That the net level of funds being returned at the 90th meeting by the implementing agencies was US \$3,360,846, consisting of US \$2,156,038, plus agency support costs of US \$161,346 from UNDP; US \$(17,118), plus agency support costs of US \$23,719 from UNEP; and US \$968,631, plus agency support costs of US \$68,230 from UNIDO;
 - (iii) That UNDP held balances of US \$31,206 including agency support costs, for two projects completed over two years previously, and US \$119,016, including agency support costs, for one "by decisions of the Executive Committee" project;
 - (iv) That UNEP held balances of US \$54,511 including agency support costs, for two projects completed over two years and US \$240,643, including agency support costs for three "by decisions of the Executive Committee" projects; and
 - (v) That UNIDO held balances of US \$46,514 including agency support costs, for one project completed over two years and US \$3,473,032, including agency support costs for 15 "by decisions of the Executive Committee" projects;
 - (b) To request:
 - (i) Bilateral and implementing agencies to proceed with disbursement or to cancel committed and not-committed funds that were not needed for completed projects and projects completed "by decision of the Executive Committee", and to return the associated balances to the 91st meeting;
 - (ii) UNDP to proceed with disbursement or to cancel commitments for the remaining two projects completed over two years previously, and to return balances to the 91st meeting;

- (iii) UNEP to proceed with disbursement or to cancel commitments for the remaining two projects completed over two years previously, and to return balances to the 91st meeting; and
- (iv) UNIDO to proceed with disbursement or to cancel commitments for the remaining one project completed over two years previously.
