DATES AND VENUES OF THE 92ND TO 97TH MEETINGS OF THE EXECUTIVE COMMITTEE

92nd and 93rd meetings

1. At its 90th meeting, by decision 90/54(b)(c) the Executive Committee decided to hold:

- (b) The 92nd meeting from 12 to 16 June 2023, in Montreal, Canada, at the International Civil Aviation Organization (ICAO); and
- (c) The 93rd meeting back to back with the 35th Meeting of the Parties to the Montreal Protocol, at a venue to be determined.

2. It has been confirmed that the Formula 1 Grand Prix will take place in Montreal, from 16 to 18 June 2023. The Secretariat therefore would like to present for the consideration of the Executive Committee alternative options on dates for holding the 92nd meeting: from 29 May to 2 June 2023 or from Sunday, 11 June to Thursday, 15 June 2023.

3. The Secretariat has been informed that the 35th Meeting of the Parties to the Montreal Protocol will take place from 23 to 27 October 2023, in Bangkok, Thailand. The 93rd meeting of the Executive Committee will therefore be held from 16 to 20 October 2023, in Bangkok, Thailand, at the United Nations Conference Centre.

94th to 97th meetings

4. The approved 2024 and proposed 2025 budgets provides for two meetings of the Executive Committee in Montreal, Canada. The Secretariat presents the following options on meeting dates for the consideration of the Executive Committee:

Recommendation

- 6. The Executive Committee may wish:

 - (ii) From 10 to 14 June 2024, in Montreal, Canada, at ICAO;
 - (d) To hold its 95th meeting:
 - (i) From 18 to 22 November 2024, in Montreal, Canada, at a venue to be determined; or
 - (ii) From 2 to 6 December 2024, in Montreal, Canada, at ICAO;
 - (d) To hold its 96th meeting:
 - (i) From 26 to 30 May 2025, in Montreal, Canada, at a venue to be determined; or
 - (ii) From 2 to 6 June 2025, in Montreal, Canada, at ICAO; or
 - (iii) From 9 to 13 June 2025, in Montreal, Canada, at ICAO;
 - (e) To hold its 97^{th} meeting:
 - (i) From 17 to 21 November 2025, in Montreal, Canada, at ICAO; or
 - (ii) From 1 to 5 December 2025, in Montreal, Canada, at ICAO.
