SECRETARIAT ACTIVITIES

Introduction

1. This document presents the activities of the Secretariat since the conclusion of the 90th meeting of the Executive Committee. The document also includes a recommendation, for the consideration of the Executive Committee, on the management response to the 2019 Assessment of the Multilateral Fund by the Multilateral Organisation Performance Assessment Network (MOPAN).

I. Actions taken following the 90th meeting and for the preparation of the 91st meeting

2. The reports for parts I and II of the 89th and the 90th meetings² were conveyed to all Executive Committee members, implementing agencies and the Ozone Secretariat, and were placed on the Multilateral Fund's website. Results of the meetings related to project approvals and HCFC phase-out management plan tranche submission delays were communicated to 78 Article 5 countries, and the relevant bilateral and implementing agencies. A post-meeting document summarizing decisions taken was prepared and shared on the Multilateral Fund's website. The Secretariat updated databases, summary documents and operational guidelines, where applicable. The 91st meeting is organized based on the plan communicated to all Executive Committee members by the letter sent on 30 August 2022.³

Management response to the MOPAN assessment

3. A draft management response from the Executive Committee to the Secretariat of MOPAN in relation to its 2019 assessment of the Multilateral Fund, requested in decision 89/1(c)(iv) of the Executive Committee, is submitted in Annex I, for the Committee's consideration and guidance on further action.

Inter-agency coordination meeting

4. The Secretariat arranged an in -person inter-agency coordination meeting held in Montreal, Canada, with online participation as well, from 20^h to 22^d September 2022. Participants included the representatives of the bilateral agencies of Canada, France, Germany and Japan, representatives of the implementing agencies and Secretariat staff. The coordination meeting allowed the Secretariat and the agencies to discuss matters regarding preparations for the 91st meeting including, country programme data reporting, matters relating to programme implementation, business planning, project submissions (including updated guides and templates), status of preparation of stage I of Kigali HFC implementation plans, issues relating to institutional strengthening, and the capacity of the Multilateral Fund institutions to address HFC phase-down. The meeting report⁴ is posted on the in-session area of the Multilateral Fund's website for the 91st meeting.

II. Meetings attended and missions undertaken

5. With travel restrictions due to the COVID-19 pandemic being lifted in several countries, a combination of online presence but also in-person participation resumed during the period.

Informal Network Meeting of the English-Speaking Caribbean

6. The Secretariat participated in the Second Quarter Informal Network Meeting of the English-Speaking Caribbean, held virtually on 27 June 2022, and made a presentation on the decisions adopted by the Executive Committee at the 89th and 90th meetings.

68th meeting of the Implementation Committee, 44th meeting of the Open-Ended Working Group, 5th Extraordinary Meeting of the Parties to the Montreal Protocol

- 7. The Secretariat and the Senior Monitoring and Evaluation Officer (SMEO) participated in the 44th meeting of the Open-Ended Working Group, the 5th Extraordinary Meeting of the Parties to the Montreal Protocol, and the 68th meeting of the Implementation Committee, held in Bangkok, Thailand, from 9 to 16 July 2022.
- 8. During this mission, the Secretariat took part in the contact group on the replenishment of the Multilateral Fund for the period 2021–2023, where information was provided as requested, and participated in other contact groups and numerous side events. The Secretariat also held several consultations with the representatives of both Article 5 countries and non-Article 5 countries, and bilateral and implementing agencies.

<u>Joint Meeting of the South Asia, Southeast Asia and Pacific Island Countries Networks of National Ozone</u> Officers

9. The Secretariat and the SMEO attended the Joint Meeting of the South Asia, Southeast Asia and Pacific Island Countries Networks of National Ozone Officers, held in Bangkok, Thailand, from 17 to 19 July 2022. Presentations were made on the Executive Committee decisions adopted at the 89th and the

90th meetings, updates on the evaluation work programme and the planning of the evaluation of regional networks. Discussions with Article 5 countries also took place on the margins of the meeting.

Meeting of the Scientific Assessment Panel of the Montreal Protocol

10. The Chief Officer attended the Scientific Assessment Panel meeting on the "Scientific Assessment of Ozone Depletion: 2022", held in Geneva, Switzerland, from 25 to 29 July 2022. She has been a reviewer and co-author of the executive summary highlights.

Thematic Technical and Coordination Meeting on the Development and Adoption of Standards as required under the Kigali Amendment and the Network Meeting of the West Asia National Ozone Officers

11. The SMEO attended the Thematic Technical and Coordination Meeting on the Development and Adoption of Standards as required under the Kigali Amendment and the Network Meeting of the West Asia National Ozone Officers, held in Dubai, United Arab Emirates, from 11 to 16 September 2022. Presentations were made to provide updates on the evaluation work programme and the planning of the evaluation of regional networks. The Secretariat participated online to present on the recent Executive Committee decisions.

<u>Europe and Central Asia Meeting on Czech Republic's Montreal Protocol Experience and the Preparation of Kigali HFC Implementation Plans</u>

12. The Secretariat and the SMEO attended the Europe and Central Asia meeting on Czech Republic's Montreal Protocol experience and the preparation of Kigali HFC implementation plans, held in Prague/Cheb, Czechia, from 20 to 22 September 2022. Presentations were made on recent Executive Committee decisions, updates on the evaluation work programme and the planning of the evaluation of regional networks. Discussions with Article 5 and non-Article 5 countries also took place on the margins of the meeting.

Joint Africa Network and Kigali HFC Implementation Plan Preparation Meeting

- 13. The Secretariat and the SMEO attended the Joint Africa Network and Kigali HFC Implementation Plan Preparation Meeting, held in Nairobi, Kenya, from 3 to 5 October 2022. Presentations were made on the recent Executive Committee decisions, updates on the evaluation work programme and the planning of the evaluation of regional networks. Discussions with Article 5 countries also took place on the margins of the meeting.
- 14. The SMEO also met with the Anglophone and the Francophone countries of the African networks to discuss various evaluation matters.

Joint Network Meeting of the South Asia and Southeast Asia National Ozone Officers

15. The Secretariat attended virtually the Joint Network Meeting of the South Asia and Southeast Asia National Ozone Officers, held in Chiangmai, Thailand, from 3 to 5 October 2022, and made a presentation on the recent Executive Committee decisions.

<u>United National Development Programme (UNDP)</u>

16. The Chief Officer, together with members of the Secretariat, paid a courtesy visit to the UNDP headquarters in New York, United States of America, on 10 and 11 October 2022, to meet with the Assistant Administrator and Director, and the Deputy Director of the Bureau for Policy and Programme Support, and staff of the UNDP Montreal Protocol Unit to discuss issues relating to business planning, administrative costs and potential challenges with the implementation of the phase-down of HFCs, as well as knowledge

management. This is one of a series of meetings to be held within this and next year with the implementing agencies.

Pacific Island Countries Network of National Ozone Officers

17. The Secretariat attended the meeting of the Pacific Island Countries Network of National Ozone Officers, held in Nadi, Fiji, from 10 to 12 October 2022, and made a presentation on the recent Executive Committee decisions. Discussions with countries of the network also took place on the margins of the meeting.

Network Meeting for Latin America Ozone Officers

18. The Secretariat and the SMEO joined the Network Meeting for Latin America Ozone Officers that was held virtually from 11 to 13 October 2022. Presentations were made on recent Executive Committee decisions, updates on the evaluation work programme and the planning of the evaluation of regional networks.

Plastics Pollution Negotiations Training and Africa Regional Consultations

19. The Secretariat was invited to make a presentation on the Multilateral Fund as the financial mechanism for the implementation of the Montreal Protocol in the Plastics Pollution Negotiations Training and Africa Regional Consultations. The presentation was made virtually. The meeting, organized by UNEP in Naivasha, Kenya, took place on 9 November 2022.

III. Information and communications

Multilateral Fund logo

- 20. The Secretariat has developed a new logo for the Multilateral Fund, to be used in connection with the website, presentations, and communication materials. The logo depicts the earth surrounded by two concentric circles, the inner one represents the protection that the atmosphere provides, and the outermost one, with three dots, represents the three atoms that comprise the ozone molecule. The logo is intended to provide an enduring visual identity for the Secretariat's outreach materials.
- 21. The October 2022 Updated UNEP 2013 Policy on the Use of the UNEP Name and Emblem/Logo, which indicates that the wreath and other elements of the UN emblem can only be used pursuant to General Assembly resolution 92(I), was taken into account when designing the new logo. In line with applicable United Nations policy, the logo will not replace the logos of the United Nations/UNEP in official Secretariat documentation. Guidelines for the use of the logo are available on the Secretariat's website.⁵

Factsheets

- 22. Factsheets on the following demonstration projects on low-global-warming potential alternatives to HCFC technologies were developed and are being uploaded on the Secretariat's website:⁶
 - Promoting low-global-warming-potential refrigerants for air-conditioning sectors in high-ambient-temperature (HAT) countries in West Asia (PRAHA-I);
 - Demonstration project at foam systems houses in Thailand to formulate pre-blended polyols for spray polyurethane foam applications using a low-GWP blowing agent; and

• Demonstration of low-cost options for the conversion to non-ODS technologies in polyurethane foams at very small users.

IV. Administrative matters

Staffing and recruitment

- 23. The process of selection for the post of Programme Management Assistant to work with the SMEO was finalized, and the new staff member, Ms. Pamela El Kortbawi, reported on duty on 30 June 2022. She has more than 10 years of experience in project management and research, monitoring and evaluation programmes.
- 24. The process of selection for the post of Senior Administrative and Fund Management Officer was finalized, and the new staff member, Mr. Fadi Abou Elias, reported on duty on 3 October 2022. He has over 22 years of experience in the field of administration, finance, and budget, including over twenty years in the United Nations Secretariat.
- 25. The process of selection for the post of Chief of Unit, Information Systems was finalized, and the new staff member, Mr. Misha Alberizzi, reported on duty on 3 October 2022. He has over 10 years of experience in the United Nations system, where he has been leading software development teams and leading on innovative software solutions.
- 26. Recruitment and contractual arrangements were made for two consultants for the monitoring and evaluation work programme; two individual contractors were hired to support with project review; and two consultants were hired to support analysis and research to complement policy documents.
- 27. A consultant was engaged to support the Secretariat with the requests made by the Executive Committee to the Secretariat in decision 89/1(c)(ii) relating to the update of the information strategy of the Multilateral Fund, a detailed plan for information and knowledge management, the website/information technology requirements, the resources needed and the timelines for implementation. The technical feasibility study consultancy resulted in recommendations for improvements.⁷

Staff development and training

28. All Secretariat staff members completed several mandatory UN online training courses and briefing sessions, including the Leadership Dialogue on Living the UN Values. As at the date of release of this document, several Secretariat staff were registered to attend a dedicated training and information session on the Surface Hub and other collaboration tools at the Microsoft Technology Center in Montreal.

Audit by the United Nations Office of Internal Oversight Services (OIOS)

29. As reported in document UNEP/OzL.Pro/ExCom/90/2, five of the six recommendations made by the OIOS audit of the Multilateral Fund conducted in 2021, had been closed by OIOS before the 90th meeting, after having been considered as implemented further to the Secretariat's submission of the relevant reports and evidence. As to the recommendation on gender, the Secretariat had communicated to OIOS that the review of the implementation of the Multilateral Fund Operational Policy on Gender Mainstreaming for Multilateral Fund-supported projects would take place at the 90th meeting, in accordance with decision 84/92, and that following such review, the Secretariat would request closure of this

recommendation further to the relevant decisions and guidance of the Executive Committee.

30. The Secretariat thus prepared a request for closure of the recommendation on gender that was communicated to OIOS through the Executive Director of UNEP on 27 July 2022. The request referred to the progress made in shifting the concept, design and use of indicators to show that results and impact were being achieved in the attainment of the objectives of the gender mainstreaming policy, as evidenced from the discussions that took place and the decision adopted by the Executive Committee at its 90th meeting. The recommendation was closed by OIOS on 29 July 2022 as it was considered implemented.

V. Cooperation with multilateral environmental agreements (MEAs) and other organizations

31. Pursuant to decision 79/1(b), the Secretariat has included a full overview of the status of all discussions with MEAs and other relevant organizations in Annex II to the present document.

Ozone Secretariat

32. The Secretariat undertook a number of exchanges with the Ozone Secretariat during the planning of the 91st meeting of the Executive Committee and of the 34th Meeting of the Parties.

United Nations and other international organizations

International Civil Aviation Organization (ICAO)

33. Discussions were held with the Director of the Bureau of Administrative Services, in ICAO's capacity as the lead United Nations agency in Montreal, on various administrative arrangements.

Global Environment Facility (GEF), Green Climate Fund (GCF) and financial institutions

34. The Secretariat held several discussions with the senior management staff of the GEF, GCF and other relevant financial institutions, including the Asian Development Bank, the African Development Bank Group, the European Bank for Reconstruction and Development, the Inter-American Development Bank, the World Bank Group and the Climate Investment Fund, further to the request of the Executive Committee to gather information on policies, projects and relevant funding modalities relating to maintaining and/or enhancing energy efficiency while phasing down HFCs (decision 90/50(b)(iii).

UNDP, UNEP, United Nations Industrial Development Organization (UNIDO) and World Bank

35. The Secretariat undertook consultations with UNDP, UNEP, UNIDO and the World Bank on the analysis related to the capacities of the MLF institutions to address HFC phase-down, requested by the Executive Committee (decision 89/4) and presented to this meeting for its consideration. Inputs were received in writing from one implementing agency.

Recommendation

- 36. The Executive Committee may wish:
 - (a) To note, with appreciation, the report on Secretariat activities contained in document UNEP/OzL.Pro/ExCom/91/2; and
 - (b) To request the Secretariat to transmit the management response of the Executive

At its 89th meeting (decision 89/1(c)(iv)), the Executive Committee requested the Secretariat to prepare, for consideration by the Executive Committee at its 91st meeting, a draft management response from the Executive Committee to the Secretariat of MOPAN in relation to its 2019 Assessment of the Multilateral Fund.

Introduction

The Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol (MLF) welcomes the 2019 Assessment of the MLF by the Multilateral Organisation Performance Assessment Network (MOPAN) and commends the MOPAN Secretariat and the assessment team for the constructive engagement and the wide-ranging and insightful review of the MLF's performance.

The Executive Committee appreciates the opportunity provided to the MLF through the MOPAN assessment, to continue to strengthen its delivery and to draw the attention of the Secretariat and its partners to areas where their further active support was needed.

The Executive Committee also expresses its strong appreciation to the Institutional Lead Country, Canada, and Canada's leadership in the conduct of the assessment, which has been key in the success of the process. The availability of Canada and the MOPAN representatives to present the assessment report at the 86th meeting of the MLF's Executive Committee, is greatly valued.

This MLF's first assessment by MOPAN proved to be a collaborative and positive one. We are also appreciative of the efforts made by the assessment team to understand the specific features of the MLF's business model and its differences from other multilateral organisations, and the professionalism with which the assessment was conducted.

The Executive Committee welcomes the key strengths and areas for improvement identified by the assessment, as well as its overall positive conclusions and consideration that the MLF, as the Montreal Protocol's financial instrument, has been key to the success of the Protocol, considered one of the most effective international environmental treaties to date. We are proud of the assessment's affirmation that the Multilateral Fund has significantly contributed to the global phase-out of ozone depleting substances (ODS), and to environmental and human health impacts by supporting developing countries in this endeavour.

Overall, the MOPAN's assessment concludes that the MLF has proved to be very effective in delivering on its mandate, and that the almost USD 4 billion contributed to the MLF in the period 1991-2019 could possibly be considered the most effective international expenditure to date.

The MOPAN assessment has provided the MLF with valuable opinions and recommendations, which have been carefully considered to enhance organisational improvement, and have been incorporated into the Fund's strategic analysis, planning and aspirations.

Key strengths

The positive findings of the assessment that the Executive Committee is satisfied to note include that:

- The MLF is a uniquely focused organisation with an extremely clear set of internationally mandated and achievable targets and has been extremely successful in supporting the compliance of Article 5 countries in phasing out controlled substances that affect the ozone layer and global climate.
- In terms of results, the MLF has achieved, or is on track to achieve, most of the targets set under the Montreal Protocol for Article 5 countries. It has contributed to substantial, global-scale environmental, human health and climate change mitigation impacts.
- The organisation makes efficient use of a relatively small budget and limited staff. It is very cost-conscious and operates via a close network of small professional teams. The periodic reporting and independent verification for each tranche of the national phase-out plans is one of the key strengths.
- The MLF is staffed with dedicated and technically focused professionals ensuring high quality scrutiny of project proposals and monitoring.

The Executive Committee is pleased to reaffirm that the MLF is building on the strengths and the important organisational lessons outlined in the report.

Areas for improvement

The assessment also provides insights into areas where there may be potential to improve the performance of the MLF. The Executive Committee has made important decisions on the basis of proposals made by the MLF Secretariat to address the areas identified and wishes to note that several actions are already underway to further increase the MLF's achievements through addressing the highlights of the assessment.

The main areas for improvement noted by the assessment refer to the results framework, the information and communications function, sustainability, the evaluation function, and gender equality.

The Executive Committee considered, at its 89th meeting a document prepared by the MLF Secretariat,¹¹ which outlined observations and actions proposed by the Secretariat related to the five key areas of improvement identified.

In its decision 89/1, the Executive Committee requested the MLF Secretariat, taking into account the discussions held on the matter:

- To develop a results framework and a scorecard that fit the operations of the Multilateral Fund for consideration by the Executive Committee at its 92nd meeting;
- To update the information strategy of the Multilateral Fund, to include a detailed plan for information and knowledge management, the website/information technology requirements, the resources needed and clear timelines for implementation and to submit the strategy for consideration by the Executive Committee at the 91st meeting;
- To explore opportunities to further highlight how the sustainability of activities supported by the Multilateral Fund would be ensured, including by further clarifying in the documents submitted by

the Secretariat how partner capacity, risks and critical assumptions were considered, and to report to the Executive Committee at its 91st meeting.

The Executive Committee also requested the Senior Monitoring and Evaluation Officer (SMEO) to include in the monitoring and evaluation work programme for the year 2023 for consideration by the Executive Committee at its 91st meeting, actions to enhance the evaluation function outlined in document UNEP/OzL.Pro/ExCom/89/2/Add.1.

On the development of a results framework and a scorecard, the Secretariat has made a preliminary analysis of the current MLF indicators, actions, and deliverables. Based on this analysis, the Secretariat will develop a results framework that identifies objectives and performance indicators that demonstrate the results of MLF-supported activities across Montreal Protocol-related and other areas of social, economic and environmental stewardship more effectively, for consideration by the Executive Committee at its 92nd meeting. The goals of the results framework will be largely achieved by reorganizing the data already available at the Secretariat, and with guidance from the Executive Committee.

In connection with information and knowledge management, the Secretariat, with the support of a consultant, undertook a technical feasibility study to assess the current state of knowledge management within the Secretariat based on reviews of the website, documents, submission processes, existing databases, and discussions with stakeholders (users). The update of the information strategy of the MLF is essentially the development of a new knowledge management system, which is proposed in the document submitted to the 91st meeting.12

The new knowledge management system aims at preserving the existing data and information and providing efficient, secure, and user-friendly access to them by all stakeholders; and organizing and transforming these data and information to knowledge that could be passed on to various types of stakeholders to facilitate decision-making processes through different tools (i.e., a revamped website and meeting portal, an online reporting tool under the country programme data extending to HFCs, a data portal, country profiles, a searchable online collection of the MLF policies, guidelines, and procedures).

The document includes recommendations for improvements, and a detailed plan on information and knowledge management, website/information technology requirements, resources needed, and clear implementation timelines.

In response to the matter on sustainability, the Secretariat submitted a document to the 91st meeting, 13 where it reports on the areas addressed under the project review process and on opportunities to highlight and communicate those areas. The Secretariat's project review encompasses a detailed review of the consumption and, where relevant, production data for the country concerned; the capacity of institutions and enterprises to undertake the planned activities; the policy and regulatory frameworks to support the sustained phase-out; and measures that may have been undertaken in case of delays and challenges in implementation. To communicate those assessments more clearly, the Secretariat has identified a few changes that will be introduced to documents for tranches and new stages of HPMPs, aimed at ensuring that sustainability, risk assessment and assessment of partner capacity are an integral part of project preparation, implementation and completion undertaken by the bilateral and implementing agencies and the overall project review process. The necessary indicators and metrics on sustainability and risk management will also be considered, to be included in the results framework and the scorecard to be submitted at the 92nd meeting of the Executive Committee.

In response to the request to enhance the evaluation function, the SMEO has prepared a draft 2023 Work Programme on Monitoring and Evaluation,¹⁴ which includes two new activities aimed at achieving the highlighted improvements. The first activity is the undertaking of a self-assessment of the evaluation function at the MLF, to be prepared based on the United Nations Evaluation Group methodology to assess the maturity of evaluation functions in the UN organizations. This would be followed by an external independent assessment to validate the findings and propose a road map to strengthen the evaluation function, as recommended in the MOPAN assessment.

In its decision 90/28(g), the Executive Committee requested the SMEO to identify how to improve the relevance and use of Project Completion Reports. The second activity proposed in the draft 2023 Work Programme aims at satisfying this request, through the evaluation of the relevance, formats and usefulness of project completion and verification reports.

Responding on gender, the Secretariat mentioned in document UNEP/OzL.Pro/ExCom/89/2/Add.1 that, in accordance with decision 84/92(e), it would review the implementation of the MLF Operational Policy on Gender Mainstreaming and would prepare a report for consideration of the Executive Committee at its 90th meeting. The report submitted to the 90th meeting referred to the application of the policy by the bilateral and implementing agencies throughout the project cycle, to how such implementation had contributed to achieving the objective of the policy, as well as to the performance indicators used by the agencies that measure the achievement of outcomes of gender mainstreaming activities in project proposals. The response to the MOPAN considerations on gender equality was discussed in the context of the review of the implementation of the gender mainstreaming policy at the 90th meeting of the Executive Committee.

The discussions demonstrated the level of awareness and commitment of the members of the Executive Committee towards gender mainstreaming, and that its consistent integration into policy interventions, programmes, projects, monitoring and evaluation processes should show results in achieving the policy objectives of gender equality and women's empowerment. Thus, indicators that capture the transformative dimension of this change as well as potential barriers to achieving this outcome are to be employed. The Executive Committee decided through its decision 90/48, to encourage bilateral and implementing agencies to continue ensuring that the gender mainstreaming policy was applied to all Montreal Protocol projects, taking into consideration the specific activities presented in the review document; to request bilateral and implementing agencies to provide a brief report on key gender mainstreaming results achieved, as part of their annual progress reports, as of 2023; and to request the Secretariat to develop, for consideration of the Executive Committee at its 92nd meeting, improved project requirements, including specific outputs and outcomes, and related key performance indicators for the systematic application of the gender mainstreaming policy; and to incorporate within the proposed scorecard an overarching results statement on gender mainstreaming, on the basis of the reports by the bilateral and implementing agencies. An update on the implementation of the gender mainstreaming policy will be submitted to the last meeting of 2024 for the consideration of the Executive Committee.

Conclusion

The Executive Committee very much appreciates and embraces the findings and recommendations of the MOPAN assessment and is glad to reassure MOPAN that the MLF institutions are working tirelessly to address them towards an ever more efficient and effective delivery of the Fund.

The valuable guidance provided by the assessment supports us in our quest to further strengthen the MLF's organizational effectiveness and in maximising the Fund's contribution to achieving the targets and ultimate objectives of the Montreal Protocol and the Kigali Amendment, with a wide-ranging impact on the ground in changing people's lives and contributing to wider social, economic, and environmental betterment.
