# PROGRESS REPORT OF UNIDO AS AT 31 DECEMBER 2021

#### Introduction

- 1. This document presents the progress report of UNIDO as at 31 December 2021.<sup>2</sup>
- 2. The progress report of UNIDO includes the status of implementation of projects, including 35 HFC-related projects that have been funded under the additional voluntary contributions by 17 non-Article 5 Parties to provide fast-start support for implementation of the Kigali Amendment.
- 3. The Secretariat reviewed the status of implementation of each ongoing project on a country-by-country basis, taking into account implementation delays that have occurred with respect to planned completion dates that had been reported in 2021, the potential impact of these delays on the phase-out of controlled substances and the rate of planned disbursements. The analysis contained in the present document is based on ODP tonnes for all controlled substances except for HFCs which are measured in  $CO_2$ -eq tonnes.<sup>3</sup>
- 4. This document consists of the following sections:
  - I. Projects approved for all controlled substances under the regular contributions to the Multilateral Fund. It presents a summary of progress in implementation of projects for 2021 and cumulative since 1993<sup>4</sup> addressing all controlled substances under the Montreal Protocol, including Annex F substances (HFCs). It also contains a review on the status of implementation of each ongoing<sup>5</sup> project at the country level. It identifies projects with

# I. Projects approved for all controlled substances under the regular contributions to the Multilateral Fund

# I.1 Progress in implementation of projects for 2021 and cumulative since 1993

5. As of 31 December 2021, the Executive Committee had approved US \$993.22 million in projects for UNIDO, consisting of US \$876.73 million for the implementation of investment and non-investment projects, and US \$116.49 million for agency support costs, as shown in table 1.

- 6. In 2021, 73 new projects and activities were approved. This level of funding is expected to result in the phase-out of 83,308 ODP tonnes of consumption and production and 211,531 CO<sub>2</sub>-eq tonnes of consumption of controlled substances. Annex I shows the status of project implementation per country in 2021.
- 7. Table 2 shows the status of project implementation including fund disbursement per project type as at 31 December 2021. Annex II presents analytical information per year since 1993.

- Implementation of projects and activities by UNIDO for 2021 and cumulative since 1993 up to 31 December 2021, is summarized as follows:
  - Phase-out: In 2021, 1,105.4 ODP tonnes of consumption of controlled substances were (a) phased out<sup>8</sup> and an additional 704.1 ODP tonnes of consumption of controlled substances were approved for phase-out. Since 1993, 64,248 ODP tonnes of consumption of controlled substances and 17,381 ODP tonnes of production of controlled substances had been phased out, 9 of an expected total of 83,308 ODP tonnes and 211,531 CO<sub>2</sub>-eq tonnes from projects approved (excluding cancelled and transferred projects);
  - Disbursements/approvals: In 2021, US \$23.92 million was disbursed and (b) US \$26.75 million was planned for disbursement based on the 2020 progress report, representing a rate of disbursement of 89 per cent of that planned. Cumulatively, US \$785.23 million had been disbursed out of the total US \$876.73 million approved for disbursement (excluding agency support costs), representing a rate of disbursement of 90 per cent. In 2021, US \$23.09 million was approved for implementation;
  - Cost-effectiveness (in ODP):<sup>10</sup> Since 1993, the average cost-effectiveness of investment (c) projects approved leading to a permanent reduction in consumption was US \$11.42/kg and for all production sector activities (CFC and methyl bromide (MB)) was US \$3.02/kg. The average cost-effectiveness of investment projects per ODP tonne was US \$8.60/kg for completed projects and US \$40.26/kg for ongoing projects;<sup>11</sup>
  - Number of projects completed: In 2021, 87 projects were completed. Since 1993, (d) 1,689 projects of the 1,924 projects approved (excluding closed or transferred projects) were completed, representing a completion rate of 88 per cent;
  - **Speed of delivery investment projects:** Projects that were completed in 2021 were (e) completed on average 57 months after their approval. Since 1993, the average time for completion of investment projects has been 40 months after their approval. First

- disbursements under these projects occurred, on average, nine months after they had been approved;
- (f) **Speed of delivery non-investment projects:** Projects that were completed in 2021 were completed on average 30 months after their approval. Since 1993, the average time for completion of non-investment projects has been 35 months after their approval. First disbursements under these projects occurred, on average, nine months after they had been approved;
- (g) **Project preparation:** Of the 576 project preparation activities approved by the end of 2021, 508 have been completed, leaving 68 ongoing activities. In 2021, 20 preparation activities have been completed;
- (h) **Implementation delays:** A total of 235 projects were under implementation at the end of 2021, experiencing, on average, a delay of 21 months. Forty-six of these projects are classified as "projects with implementation delays" that are subject to the procedures of project cancellation (as demonstration projects, project preparation, and IS are not subject to those procedures); and
- (i) **Multi-year agreements (MYAs):** In 2021, two MYAs for the control and phase-out of HFC-23 emissions and 68 MYAs for HCFC phase-out management plans (HPMPs) were under implementation. Since 1993, 192 MYAs have been approved and 122 MYAs have been completed, representing a completion rate of 64 per cent.
- 9. Table 3 summarized progress made by UNIDO since 1993.

# HFC-related projects

10. As of 31 December 2021, the Executive Committee had approved 33 HFC-related projects (including three investment projects, 27 preparation projects and three enabling activities) under regular contributions amounting to US \$6,812,029 (excluding agency support costs). A summary of the status of these projects is presented in table 4 and the respective data has already been included in paragraphs 5 to 9.

- 11. As of the end of 2021, of the 33 projects, two preparation projects and one enabling activity have been completed, leaving 30 ongoing. Extension of the completion dates of two ongoing enabling activities was approved; these activities are expected to be completed in 2022.
- 12. The three ongoing HFC investment projects related to the control and phase-out of HFC-23 emissions in Mexico and Argentina approved at the 86<sup>th</sup> and 87<sup>th</sup> meeting respectively, and the conversion of large commercial unitary roof top air-conditioning units in Jordan at the 81<sup>st</sup> meeting.
- 13. Of the total cumulative funding approved of US \$6,812,029 (excluding agency support costs), US \$1,981,766 had been disbursed, representing a disbursement rate of 29 per cent.

# I.2 Issues identified in project implementation in 2021

- 14. Further to the review process, several issues were discussed and satisfactorily addressed, except for issues on 46 projects classified as projects with implementation delays (including 44 projects related to components of MYAs that are subject to procedures for project cancellation, in line with decision 84/45(c); and two investment projects). Annex III to the present document presents those projects classified with implementation delays, and the Secretariat's recommendations requesting the submission of a report to the 92<sup>nd</sup> meeting.
- 15. In addition, issues have been identified regarding projects, tranches of MYAs, and preparation of HPMPs. These issues are also presented in Annex III. For each of these projects, a brief description on the status of implementation and the outstanding issues are presented and a recommendation is proposed for consideration by the Executive Committee.
- 16. Details of progress in implementation of projects associated with the HPMPs for Albania, <sup>13</sup> China (extruded polystyrene foam sector plan), <sup>14</sup> the Congo, <sup>15</sup> Eritrea, <sup>16</sup> Mauritania, <sup>17</sup> Montenegro, <sup>18</sup> Morocco, <sup>19</sup> Nigeria (stage III), <sup>20</sup> Serbia, <sup>21</sup> South Africa, <sup>22</sup> Syrian Arab Republic, <sup>23</sup> Togo, <sup>24</sup> Turkmenistan, <sup>25</sup> and Venezuela (Bolivarian Republic of), <sup>26</sup> and a report on projects with specific reporting requirements <sup>27</sup> associated with Senegal (HPMP), have been submitted to the 91<sup>st</sup> meeting. Recommendations for outstanding issues for these projects, including approval of extension requests, if any, are addressed in the relevant sections of those documents. The issues relating to the HPMPs for Argentina, Suriname, Tunisia and Türkiye, tranches of which were due at the 91<sup>st</sup> meeting but were not submitted, and for Iraq, the tranche of which was submitted to the 91<sup>st</sup> meeting but subsequently withdrawn during the project review process, are addressed in the document on tranche submission delays. <sup>28</sup> Outstanding issues for the remaining ongoing projects not included in Annex III to the present document, and requests for extension of dates of

completion, are addressed below.

- 17. Of the 150 ongoing projects, excluding IS and project preparation, 98 projects have revised planned dates of completion since the 2020 progress report.
- 18. In line with decision 82/11(c)(ii), the Secretariat noted that renewal of the IS project for Tunisia had not been submitted for the last two years. UNIDO indicated that sufficient balance is still available due to slow progress in implementation, and it is planning to submit the renewal request in 2023.
- 19. In line with decision 82/11(b),<sup>29</sup> UNIDO has requested the extension of the duration of four HPMPs, as shown in table 5.

# II. Projects approved under the additional voluntary contributions for fast-start support for HFC phase-down

20. As of 31 December 2021, the Executive Committee had approved 35 HFC-related projects under the additional voluntary contributions, amounting to US \$8,066,306 (excluding agency support costs). A summary of the status of these projects is presented in table 6.

- 21. As of the end of 2021, of the 35 projects approved, 28 projects had been completed including two investment projects, four preparation activities and 22 enabling activities, leaving seven ongoing. Extension of the completion dates of the six ongoing enabling activities was approved; these activities are expected to be completed in 2022.
- 22. The ongoing investment project is in the refrigeration sector in Argentina; it was approved at the 81<sup>st</sup> meeting and will be completed in 2022.
- 23. Of the total cumulative funding approved of US \$8,066,306, US \$5,607,318 had been disbursed representing a disbursement rate of 70 per cent.

# III. Recommendation

- 24. The Executive Committee may wish:
  - (a) To note the progress report of UNIDO as at 31 December 2021 contained in document UNEP/OzL.Pro/ExCom/91/16;
  - (b) To approve the extension of the completion dates of the HCFC phase-out management plans (HPMPs) for the countries listed below to allow for completion of the remaining ongoing activities as reflected in table 5 of document UNEP/OzL.Pro/ExCom/91/16:
    - (i) Botswana (stage I) (BOT/PHA/82/INV/21) to 30 June 2023;
    - (ii) Libya (stage I) (LIB/PHA/75/INV/36) to 31 December 2023;
    - (iii) Somalia (stage I) (SOM/PHA/88/INV/16) to 30 June 2023;
    - (iv) The Sudan (stage II) (SUD/PHA/75/INV/38) to 31 December 2023; and
  - (c) To approve the recommendations related to ongoing projects with specific issues contained in Annex III to the present document.

# I. Project Approvals and Disbursements

# Annual summary data

- as number of approvals, corresponding ODP (wherever applicable), approved funding, adjustment and disbursement characteristics. The cumulative funds for the period 1993-2021 approved for UNIDO activities under the Multilateral Fund amount to US\$ 876,732,689, excluding agency support cost, the core unit funding and projects funded by the additional contributions for implementation of the Kigali Amendment. This amount, however, includes the adjustments made until end 2021. The details are contained in the attached database (Annex II in the Excel file). In this annex, the data are sorted by regions and within each region the completed, financially completed; ongoing and closed (cancelled) projects are listed.
- 2) From 2017 a total of US\$ 8,085,163 were approved for UNIDO activities from the additional contributions to provide fast-start support for implementation of the Kigali Amendment. The details are contained in the attached database (Annex IIa in the Excel file)
- 3) As of 31 December 2021, UNIDO's cumulative disbursement for all projects (completed and ongoing) amounts to US\$ 785,234,446 excluding agency support cost, core unit funding and disbursements in projects funded by additional contributions. This corresponds to a delivery rate of 90 per cent. Out of this amount, US\$ 705,697,953 relate to cumulative disbursement for investment projects (Table 2, "Summary Data by Project Type" in the Excel file).

#### **Interest**

4) The interest earned for the period 1993 – 2021 amounts to US\$ 41,859,735 and is shown by years in the Table 1 "Annual Summary" in the Excel file. The interest earned in 2021 amounts to US\$ 121,836.

10) Partial ODP phase out is reported in Table 3b "Partial ODP Phase-out by Sector, Region, Country" and in Annex II in the Excel file.

The partial phase-out achieved in 2021 is 62.6 ODP tonnes for phase-out sector.

# **II. Project Completion since last Report**

# **ODP** phased out since last report - investment projects

11) As per Table 4 in the Excel file, the cumulative ODP phase out through investment projects completed in the reporting period (1 January – 31 December 2021) amounts to 1,162 ODP tonnes. In addition, 62.6 ODP tonnes were partially phased-out from ongoing projects. The details are shown in Table 3b and Table 4 in the Excel file. Table 4 in the Excel file lists all investment, demonstration, technical assistance and institutional strengthening projects completed in 2021.

# Non-investment project completions since last report

12) Since the last report, 32 non-investment projects, with approved funding of US\$ 1,841,512 were completed: 8 in Africa, 8 in Asia and the Pacific, 7 in Europe, 8 in Latin America and the Caribbean and the Core Unit Funding.

# III. Global and Regional Project Highlights

# **Global Projects**

- 13) Core Unit Funding for the year 2022 was approved in December 2021. The core unit funding for the year 2021 that was approved in 2020 for UNIDO as a global project in the amount of US\$ 2,022,000 was completed in December 2021.
- 14) The following global project has been ongoing in the reporting year:
  - Global chiller replacement project (Argentina)

# **Regional Projects**

No regional projects were ongoing during 2021.

#### IV. Performance Indicators

# Business Plan Performance Goals as decided by the Executive Committee

- 15) The 71<sup>st</sup> Meeting of the Executive Committee in December 2013 reviewed and modified the performance indicators established by earlier decisions. The new weightings, based on Decision 71/28, are indicated in the below table.
- 16) The targets and achievements for the year 2021 performance indicators approved during the 86<sup>th</sup> Meeting of the ExCom are indicated below.

# A1. Planning – Approvals

17) Tranches approved: Number of tranches approved vs. those planned

In 2021, 23 tranches were approved in total against the updated target of 29. The original target was 52, however, the below projects were not approved beyond UNIDO's control:

- UNIDO was ready for submission of the following tranches from HPMPs Stage
  I: Suriname; HPMPs Stage II for Antigua and Barbuda, Bahamas, Benin,
  Burkina Faso, Chad, Congo, Eritrea, Iran, Jordan, Liberia, Madagascar,
  Myanmar, Sao Tome and Principe, Suriname and Togo; and HPMP Stage III
  for Nigeria, but the lead agencies were not ready for submission;
- The tranche request for Algeria (x2), Mexico, Pakistan and Venezuela were submitted, but UNIDO was requested to withdraw the submissions;
- UNIDO was ready for the next tranche request under the HPMP Stage II for the Philippines, however an ExCom decision/guidance was needed before UNIDO could proceed with the submission.
- 18) Projects/activities approved: Number of projects/activities approved vs. those planned (including project preparation activities)

During 2020, 22 individual projects were approved against the originally agreed target of 39. However the target should be updated to 27 taking into account the projects not approved for reasons beyond UNIDO's control:

- The investment project for one production line of a compressor manufacturing company (ZMC) in Egypt was submitted, but the Executive Committee decided not to approve it since no consensus had been reached;
- The project on conversion of HFC-134a (or R-410a) to R-290 in the manufacturing of air-conditioning units at J.M. Group/Mina factory in Sudan was submitted, but decision has been deferred to the next in-person meeting;
- The preparations for HFC phase down plans for Serbia and Turkey could not be submitted due to the fact that the ratification of the Kigali Amendment occurred after the submission deadline for the 88<sup>th</sup> meeting;
- The preparations for HFC phase down plans for Egypt, Guatemala, Tanzania and Venezuela could not be submitted due to the fact that the countries did not ratify the Kigali Amendment;
- UNIDO was ready for submission of the preparations for HFC phase down plans for Benin, Ethiopia, Gambia and Togo, but the submission was postponed due to the lead agency planning.

The approvals include 2 renewals of institutional strengthening projects (North Macedonia and Serbia), 84 project preparations projects for HPMPs Stage III, 14 project preparations for Kigali HFC implementation plan, one project for Control and phase-out of HFC-23 emissions in production of HCFC-22 at FIASA and one global project for UNIDO's 2022 Core Unit Funding.

# A2. Implementation

19) Funds disbursed: Based on estimated disbursement in Progress Report

During 2021 the funds disbursed as per IPSAS were US\$ 23,904,056 against the estimated disbursements for year 2021 established in the Progress Report for year 2020 of US\$ 24,801,519.

20) ODS phased-out: ODS phase-out for the tranche when the next tranche is approved vs. those planned per business plans

521.29 ODP tonnes can be recorded as achievements for all MYA projects approved in 2021. However, 143.62 ODP tonnes need to be deducted from the original target of 760.7 OPD as explained in section 17 due to the non-submission and/or non-approval of several tranches beyond UNIDO's control. The adjusted target should be 617.08 ODP tonnes.

21) Project completion for activities: Project completion vs. planned in progress reports for all activities (excluding project preparation)

During 2021, UNIDO completed 65 projects against the target of 107. It should be noted that 2021 continued to be an extraordinary year, as was 2020. Due to the covid-19 pandemic, activities were often moved, rescheduled, postponed due to the constantly changing rules, introduction of curfews and lockdowns. Some activities could continue with implementation, but with great limitations posting extraordinary challenges to countries and implementing agencies.

22) The performance indicators with the weightings are summarized in the following table:

In addition to the above, UNIDO's approvals in 2021 amounted to US\$ 23,091,580 (excluding agency support costs and projects approved during 2021 but as part of the extended IAP for the 86<sup>th</sup> meeting).

# **Cumulative completed investment projects**

23) Since 1993, UNIDO's cumulative number of completed investment projects has grown to 848 with a total of US\$ 674,416,208 of approved funding including adjustments. The average number of months from approval to first disbursement was 9 months. The average number of months from approval to completion was 40 months. The cost effectiveness of completed projects is US\$ 8.6/kg. Table 5 "Cumulative completed investment projects by region, sector and implementation characteristics" in the Excel file illustrates more details, presenting information both on a regional and on a sector basis. The vast majority of completed investment projects have been implemented with disbursements of funds during implementation; only ten retroactively funded projects were implemented by UNIDO. In addition, UNIDO has completed one investment project funded by additional contributions for the Kigali Amendment.

# **Cumulative completed non-investment projects**

24) Since 1993, UNIDO's cumulative number of completed non-investment projects is 332. Out of a total of US\$ 52,687,822 approved funding, 100 per cent of funds have been disbursed. Except for 78 institutional strengthening projects, all UNIDO completed non-investment projects were objective-sensitive. Table 6 "Cumulative completed non-investment projects by region, sector and implementation characteristics" in the Excel file provides details according to geographic region and sectors. In addition, UNIDO has completed 14 Technical Assistance and project preparations funded by additional contributions for the Kigali Amendment.

#### **Cumulative ongoing investment projects**

25) By the end of 2021, UNIDO's cumulative portfolio of ongoing investment, demonstration and recovery and recycling projects contained 120 projects. Of the US\$ 105,742,671 approved budget, 35 per cent has been disbursed. It took an average of 11 months from approval to first disbursement. The Africa region had 47 ongoing projects, Asia and the Pacific 39 ongoing projects, Europe 13 ongoing projects and Latin America and the Caribbean 21 ongoing projects. Table 7 "Cumulative ongoing investment projects by region, sector and implementation characteristics" in the Excel file illustrates the implementation characteristics among regions and sectors for UNIDO's ongoing investment projects. The ongoing projects are objective sensitive and the disbursement of funds takes place during implementation. In addition, UNIDO is implementing one investment project funded by additional voluntary contributions for the Kigali Amendment.

# Cumulative ongoing non-investment projects

26) At the end of 2021, UNIDO's cumulative portfolio of ongoing non-investment projects (excluding preparatory funding) consisted of 48 projects. Out of a total of US\$ 11,968,343 of approved funding, 41 per cent has been disbursed. The ongoing non-investment projects include 19 Technical Assistance projects (tranches of HPMPs), 17 Institutional Strengthening projects, 7 Verification Reports, 2 Enabling activities projects, 1 Demonstration project and 1 Core Unit Budget. Table 8 "Cumulative ongoing non-investment projects by region, sector and implementation characteristics" in the Excel file illustrates details, presenting the projects according to regions, sectors and types. In addition, UNIDO is implementing six Technical Assistance projects funded by additional contributions for the Kigali Amendment.

# V. Status of Agreements and Project Preparation by Country

# Agreements to be signed/executed/finalized and ready for disbursing

27) As soon as a project is approved by the Executive Committee and after having notified the respective authorities, UNIDO secures officially from the recipient country's Ozone and project authorities, validity/confirmation of basic project data, such as actual ODS consumption; validity of counterpart commitment, etc., since by this time, a substantial period of time might have elapsed from the time of formulation of the project, and the projects, in most cases, are adjusted as a result of the negotiations during the approval process. After this, wherever it is required by the Country, UNIDO prepares and signs with the Ozone Authorities the agreement of cooperation. UNIDO prepares detailed Terms of Reference (TOR) for services to be rendered under the project. The TOR and the list of potential suppliers are approved by the counterpart. The bidding and subcontracting takes place based on the mutually agreed TOR. The first payment is due upon entry into force of the first contract. Even if the first payment is released, as per the IPSAS, disbursements are not reflected until after services have been delivered. Under UNSAS, any payment outflow was recorded as disbursement. The above-illustrated preparatory work explains, for multi-year programmes and projects, the time elapsing between project approval and first disbursement.

# Project preparation by country, approved amount and amounts disbursed

28) As of the end of 2021, UNIDO had on-going project preparation in 53 countries with approved funding amounting to US\$ 4,396,500 out of which US\$ 668,669 has been disbursed.

The list and details of active project preparation accounts are shown in Table 9 "Active project preparation accounts" in the Excel file.

# **Climate impact of Montreal Protocol activities**

32) In the selection of alternative technologies to replace ODS, energy efficiency, has been taken into account since the first investment projects, from early 1990s in UNIDO. In the recent years, the introduction of low Global Warming Potential and high energy efficiency alternatives has gained high attention to achieve additional climate benefits in the ODS phase-out process. UNIDO has been looking into the assessment of climate impacts of the MP activities in order to respond to the needs of Dec XIX/6 of the Meeting of the Parties. In Decision 72/40 (May 2014) bilateral and implementing agencies have been encouraged

to submit proposals for demonstration projects for low GWP alternatives to HCFCs in the refrigeration and air-conditioning subsectors and feasibility studies, including business cases for district cooling.

- 33) During the reporting period, the following demonstration projects were ongoing:
  - Global chiller replacement project (Argentina).
  - Demonstration project on promoting HFO-based low-global warming potential refrigerants for air-conditioning sector in high ambient temperatures (Saudi Arabia).

# Activities related to HFC phase down

34) In 2021, funding was approved for 23 countries to start with the preparation of Stage I of their Kigali HFC implementation plans. In addition to that, preparatory funding was approved for one country for an HFC investment project.

# Implementing agency and other cooperation

- 36) Cooperation with UNDP and the World Bank:
  Several ongoing HPMP activities in different countries and regions are being implemented together with UNDP and/or the World Bank, among others the following Stage II HPMP in Brazil, Chile, Egypt, Iran, Jordan and Nigeria.
- 37) Cooperation with UNEP: UNIDO has been implementing 87 HPMPs together with UNEP until 2021. In 2021, 15 tranches of ongoing and new HPMPs were approved with UNEP as lead or co-implementing agency in Bahrain, Bolivia, Chile, Egypt, Ethiopia, Iraq, Kuwait, Mauritania, Niger, Oman, Qatar, Saint Lucia, Senegal, Sierra Leone, United Republic of Tanzania.
- 38) Participation in inter-agency meetings: During 2021, no IACM were organized. It is to be noted that IACM are very useful mechanism for coordinating among agencies and the MLF Secretariat. In the absence of IACM, coordination and discussion of ongoing issues has proven to be more challenging.
- 39) Cooperation with Bilateral Agencies: During 2021, UNIDO continued implementation of the ongoing bilateral projects. One tranche under the Stage II of HPMP, RAC sector for China has been approved for Austria. This tranche will be implemented by UNIDO, on behalf of Austria, following the signing of the Trust Fund agreement.

#### Other issues

- 41) The status of ongoing projects is described in Annex II. The success and timely implementation of these activities are crucial in the current compliance period. In order to ensure timely project completion of projects approved so far, and to facilitate compliance of the recipient countries with their MP obligations, in 2021, UNIDO has continued to practice the following initiatives, which supported successful project implementation:
  - Regular follow up of the implementation process is being done by the staff of the
    ozone office together with UNIDO's national and international consultants and
    project managers. This ensures that effective actions on critical issues such as
    resolving bottlenecks in site preparation, customs clearance, installation,
    commissioning and safety certification, monitoring of HCFC-related equipment are
    taken.
  - Following the approval of the cost-guidelines for preparation of HFC phase-down plans, UNIDO has intensified the work with countries related to the support and service that UNIDO can offer in implementation of the Kigali Amendment.
  - Communication and interaction between regional and country offices about the implementation process has ensured the smooth flow of project plans. As in previous years, directors of UNIDO regional and country offices are regularly briefed on ongoing and possible future activities. They are involved in the implementation process and are following up the progress of the programmes. In turn, the representatives brief headquarter staff working in a specific country on the regular activities in the field and problems faced, if any.
  - Taking into consecration the travel and physical meetings limitations imposed worldwide due to the Covid-19 pandemic, UNIDO continues to provide support to the countries while prioritizing the health of its staff, consultants and counterparts. To compensate for the physical meetings and trainings, UNIDO is organizing webinars, frequent video calls and online trainings until travel will be allowed again.
  - Due to security and/or political issues, in addition to the pandemic, UNIDO experienced delays in project implementation during 2021 in several countries.
- 42) UNIDO is regularly attending Regional Network Meetings and respective workshops, organized online during 2021, providing additional support to our counterpart countries.
- 43) UNIDO also provides, when requested, support such as policy assistance, putting in place relevant legislation etc.

To compensate for the lack of field visits and physical meetings, UNIDO organized during 2021 a number of online meetings and webinars. As an example, on the 18<sup>th</sup> November 2021, UNIDO and the National Ozone Unit of Argentina organized an introductory webinar: "Climate friendly, low GWP refrigerants for room airconditioning". The webinar was conducted in English and Spanish and was attended by 73 participants from 28 countries. The goal of the webinar was to help manufacturers, academia, and policy makers (with technical interest) to be able to determine which product changes are important to consider when using R290 or R32. Several case studies were presented to demonstrate the benefits in energy efficiency and associated emissions reduction.

Virtual meetings organized as a consequence of the Covid-19 pandemic were helpful and also a good learning opportunity for UNIDO. The added value was that these meetings could be open for a larger audience. However, they also have their significant limitations compared to the in-person meetings.

44) UNIDO published a flag-ship publication in 2021 titled "Montreal Protocol and beyond: 17 stories along the journey from ozone layer protection to sustainable development". The publication encompasses 17 stories from projects implemented by UNIDO and under the Montreal Protocol umbrella that contribute to the achievement of each of the 17 sustainable development goals.
