TRANCHE SUBMISSION DELAYS

Introduction

1. Pursuant to decision 47/50(d),² the Secretariat has prepared the present document. It presents actions taken in response to decisions on tranche submission delays adopted at the 92^{nd} meeting; an analysis of each of the tranches that were due but were not submitted to the 93^{rd} meeting and the tranches that were submitted but subsequently withdrawn during the project review process. It also provides an overview of the reasons for the delays and the impact on compliance with the countries' obligations under the Montreal Protocol, and the Secretariat's recommendation.

I. Follow-up to decisions taken on tranche submission delays at the 92nd meeting

2. At the 92^{nd} meeting, 16^3 of the 34 countries that had been scheduled to submit tranche requests, had not done so on time, representing a non-submission rate of 47 per cent. Subsequently, the Executive Committee *inter alia* requested the Secretariat to send letters to the relevant Governments regarding the decisions on tranche submission delays contained in annex VIII to the report of the 92^{nd} meeting (decision 92/20(b)).

3. Pursuant to decision 92/20(b), the Secretariat sent letters to the Governments of 17 Article 5 countries⁴ to urge the submission of the next tranche of their HCFC phase-out management

plans (HPMPs). As a result, the Governments of Bahrain,⁵ Burundi,⁶ Morocco,⁷ Nigeria,⁸ Qatar,⁹ Saint Kitts and Nevis,¹⁰ Sierra Leone,¹¹ and Türkiye,¹² submitted respective tranches of their HPMPs to the 93rd meeting.

4. However, the Governments of Afghanistan, Algeria, Bosnia and Herzegovina, Botswana, Dominica, Egypt, Iraq, Kuwait, and the Lao People's Democratic Republic did not submit their tranche requests.

II. Analysis of tranches not submitted to the 93rd meeting

5. Twenty-five activities associated with tranches of HPMPs for 15 countries including those in paragraph 4, at a total value of US \$10,104,096 (including agency support costs), due for submission to the 93rd meeting were not submitted, as shown in annex I to the present document.¹³

6. In addition, the fourth tranche of stage II of the HPMP for China in the room air-conditioner manufacturing and heat pump water heaters sector plan and the fifth tranche of stage II of the HPMP for the Islamic Republic of Iran amounting to US \$8,601,730 (including agency support costs), were submitted to the 93rd meeting, but subsequently withdrawn by the relevant implementing agencies during the project review process. These tranches are also included in annex I to the present report.

III. Reasons for delays and impact on compliance

7. The reasons for delays in the submission of tranches of HPMPs include: disbursement below the 20 per cent threshold of approved funds for the previous tranche (14); Government decisions, and/or endorsements, and/or changes in the national ozone unit, and/or structural change (8); internal or external difficulties (3); enterprise delays (2); submission of progress and financial reports (2); lead or cooperating agency not ready for submission (2); sufficient funds from previous tranche approved (2); signing of agreement or project document (2); constraints imposed by the COVID-19 pandemic (1); lack of verification report (1); political situation or security issues (1); and investment component (1). For the delays in the submissions, more than one reason may apply.

8. As reported by the relevant implementing agencies, delays in the submission of tranches that were past due would have no impact on compliance with the countries' obligations under the Montreal Protocol. All outstanding tranches are expected to be submitted to the 94th meeting except for Afghanistan which will be submitted to the 95th meeting.

IV. Recommendation

- 9. The Executive Committee may wish:
 - (a) To note:
 - (i) The report on tranche submission delays contained in document UNEP/OzL.Pro/ExCom/93/24;
 - (ii) The information on tranche submission delays under HCFC phase-out management plans (HPMPs) submitted by the Governments of France and Germany and UNDP, UNEP and UNIDO;
 - (iii) That 31 out of 56 activities (16 out of 31 countries) related to tranches of HPMPs due for submission at the 93rd meeting had been submitted on time;
 - (iv) That relevant bilateral and implementing agencies had indicated that the late submission of the tranches of HPMPs due for submission at the second meeting of 2023 would have no impact on countries' compliance with the Montreal Protocol, and that there was no indication that any of the countries concerned were in non-compliance with the Montreal Protocol control measures; and
 - (b) To request the Secretariat to send letters to the relevant Governments regarding the decisions on tranche submission delays contained in annex I to the present report.
