#### **3.** Secretariat activities

<u>Document UNEP/OzL.Pro/ExCom/93/2</u> presents a report on the activities of the Secretariat since the  $92^{nd}$  meeting of the Executive Committee.

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issuance of the document.

#### Issues to be addressed: None

<u>The Executive Committee may wish</u> to consider requesting the Secretariat to prepare a document, to be submitted to the Executive Committee at its 95<sup>th</sup> meeting, on mapping the reporting requirements and streamlining reporting on progress across the spectrum of reports taking into account the ongoing development of the knowledge management system.

#### 4. Financial matters

#### (a) Status of contributions and disbursements

<u>Document UNEP/OzL.Pro/ExCom/93/3</u> provides information on the status of the Fund as at 8 November 2023. The fund balance stood at US \$523,322,098 in cash, after considering all the funds approved by the Executive Committee, up to and including the  $92^{nd}$  meeting. The amount of US \$246 million pertaining to the remaining funds from the 2018-2020 triennium and to be used after 2023 as per decision ExV/1(2), will be excluded. Accordingly, the balance available for this meeting is US \$277,322,098.

#### Issues to be addressed: None

#### The Executive Committee may wish:

- (a) To note the report of the Treasurer on the status of contributions and disbursements, contained in annex I to the present document;
- (b) To note the discussions between the representatives of the Government of Israel and the Deputy Executive Director of UNEP as well as the communication with the Secretariat, and to invite the Government to commence its contributions to the Multilateral Fund;
- (c) To note the discussions between the representatives of the Russian Federation and the Deputy Executive Director of UNEP as well as the communication with the Treasurer, and to invite the Government to pay its outstanding contributions to the Multilateral Fund;
- (d) To request the Chief Officer and the Treasurer to continue following up with Parties that had outstanding contributions for one triennium or more, and to report back at the 94<sup>th</sup> meeting.

#### (b) Report on balances and availability of resources

<u>Document UNEP/OzL.Pro/ExCom/93/4</u> presents a summary of the funds being returned by the bilateral and implementing agencies and addresses financial aspects of projects transfer. It includes statistical data from all projects with balances that have been held for over 12 months following completion of the project, and addresses balances to be returned against "by-decision projects". It indicates that US \$281,608,734<sup>1</sup> are available for approvals at the 93<sup>rd</sup> meeting, after taking into account the Fund's balance and the total amount returned by bilateral and implementing agencies.

#### The Executive Committee may wish:

- (a) To note:
  - (i) The report on balances and availability of resources contained in document UNEP/OzL.Pro/ExCom/93/4;
  - (ii) That the net level of funds being returned by the implementing agencies at the 93<sup>rd</sup> meeting is US \$4,235,786 consisting of US \$562,920, plus agency support costs of US \$39,505 from UNDP; US \$2,245,847, plus agency support costs of US \$175,064 from UNEP; US \$551,323, plus agency support costs of US \$38,603 from UNIDO; and US \$320,000, plus agency support costs of US \$302,524 from the World Bank;
  - (iii) That UNDP held balances of US \$109,930, including agency support costs, for seven projects completed over two years previously, and US \$7,953, including agency support costs, for two completed projects funded using the additional voluntary contributions made by a group of donor countries to finance fast-start activities for the implementation of HFC phase-down;
  - (iv) That UNIDO held balances of US \$1,828,437 including agency support costs for two projects funded completed over two years previously and US \$122,134, including agency support cost for five completed projects using the additional voluntary contributions made by a group of donor countries to finance fast-start activities for the implementation of HFC phase-down; and
  - (v) That the level of funds being returned at the 93<sup>rd</sup> meeting by the Government of France is US \$50,850, consisting of US \$45,000 plus agency support costs of US \$5,850.

  - (i) UNDP and UNIDO:
    - a. To proceed with disbursement or to cancel committed and not-committed funds that were not needed for completed projects, and to return the associated balances at the 94<sup>th</sup> meeting;
    - b. To proceed with disbursement or to cancel commitments for the projects completed over two years previously, and to return balances at the 94<sup>th</sup> meeting; and
    - c. To proceed with disbursement or return at the 94<sup>th</sup> meeting the balances of completed projects funded using the additional voluntary contributions;
  - (ii) The Treasurer to follow up with the Government of France, on the return, in cash, of the amount of US \$50,850 referred to in sub-paragraph (a)(v) above.

#### (i) Final 2022 accounts

#### The Executive Committee may wish:

- (a) To note the final audited financial statements of the Multilateral Fund as at 31 December 2022, prepared in accordance with the International Public Sector Accounting Standards, contained in document UNEP/OzL.Pro/ExCom/93/5;
- (b) To request the Treasurer to record in the 2023 accounts of the Multilateral Fund the differences between the implementing agencies' provisional 2022 financial statements and their final 2022 statements reflected in table 1 of document UNEP/OzL.Pro/ExCom/93/5; and
- (c) To note that the 2022 audit financial report of UNEP referred to the matter of outstanding receivables.

#### (ii) **Reconciliation of the 2022 accounts**

<u>Document UNEP/OzL.Pro/ExCom/93/6</u> provides information on the reconciliation of the 2022 accounts with the financial data of the implementing agencies in their annual progress and financial reports as at 31 December 2022, and the Secretariat's Inventory of Approved Projects database. It also provides the outstanding reconciling items.

Issues to be addressed: None

- (a) To note the reconciliation of the 2022 accounts contained in document UNEP/OzL.Pro/ExCom/93/6;
- (b) To request the Treasurer to deduct from future transfers:
  - (i) At the 93<sup>rd</sup> meeting, to UNDP, US \$457,877, on account of income from interest reported in its 2022 final accounts that had yet to be offset against new approvals;
  - (ii) At the 95<sup>th</sup> meeting, to the World Bank, US \$45,143, on account of income from cumulative interest accrued during stage I and stage II of the HCFC production phase-out management plan (HPPMP) between 2015 and 2019 reported in its final accounts that had yet to be offset against future approval of the third tranche of stage II of the HPPMP as per decision 86/99(c);
- (c) To request UNDP to make the following adjustments:
  - In its 2023 progress report, US \$316,592 representing expenditure that had been recorded in the 2022 final accounts but not in the progress report, and US \$1,805,836 representing expenditure that had been overstated in the 2022 progress report;
  - (ii) In its 2023 accounts, US \$455,191 representing expenditure from support costs that had been recorded in the 2022 progress report but not in the final accounts, and US \$886 representing over expenditures reflected in the financial statement but not in the progress report;

- (d) To request UNIDO to make adjustments in its 2022 accounts, US \$2,050,407 representing income that had been recorded in 2021, and US \$122,492 representing interest for China deducted in its 2021 accounts but not yet offset against payments by UNIDO;
- (e) To note that the following 2022 outstanding reconciling items would be updated prior to the 95<sup>th</sup> meeting by relevant implementing agencies:
  - (i) Differences of US \$288 in income and US \$1,524,873 in expenditure, between the progress report and the final accounts of UNIDO;
  - (ii) Differences of US \$1,607,246 in income between the progress report and the final accounts of the World Bank;
- (f) To note the standing reconciling items as follows:
  - (i) For UNDP, for unspecified projects, in the amounts of US \$68,300 and US \$29,054;
  - (ii) For the World Bank, for the following projects implementing with other bilateral agencies where applicable:
    - a. Bilateral cooperation of the Government of Japan (THA/PHA/68/TAS/158), in the amount of US \$342,350;
    - b. Bilateral cooperation of the Government of Japan (VIE/PHA/76/TAS/71) and (VIE/PHA/84/INV/75), in the amount of US \$234,170;
    - c. Bilateral cooperation of the Government of Sweden (THA/HAL/29/TAS/120), in the amount of US \$225,985;
    - d. Bilateral cooperation of the Government of the United States of America (CPR/PRO/44/INV/425), in the amount of US \$5,375,000;
    - e. Bilateral cooperation of the Government of the United States of America (CPR/PRO/47/INV/439), in the amount of US \$5,375,000; and
    - f. The Thailand chiller project (THA/REF/26/INV/104), in the amount of US \$1,198,946.

#### (d) Approved 2024, 2025 and proposed 2026 budgets of the Fund Secretariat

<u>Document UNEP/OzL.Pro/ExCom/93/7</u> provides information on the revised 2024 and 2025 budgets, and the proposed 2026 budget of the Fund Secretariat submitted for consideration by the Executive Committee. The document provides the results of the Secretariat's analysis of its non-staff budgets vis-à-vis the global inflation rates and based on comparison of actual costs incurred; this also took into account market research findings and existing binding contractual agreements. It also contains a proposal for additional resources based on this analysis.

- (b) To consider the following additional resources of US \$671,064 for the Secretariat in 2024 and thereafter:
  - (i) Other personnel additional resources of US \$62,800;
  - (ii) Meetings and travel additional resources of US \$582,401;
  - (iii) Operational, equipment, and supplies additional resources of US \$25,863;
- (c) To approve:
  - (i) The revised 2024 budget of [US \$9,281,086] as contained in Annex I to the present report related to the additional resources referred to in sub-paragraph (c) above;
  - (ii) The revised 2025 budget of [US \$8,895,687] as contained in Annex I to the present report related to the additional resources referred to in sub-paragraph (c) above, noting that phase 3 of the knowledge management system has not been included therein; and
  - (iii) The proposed 2026 budget of US \$9,056,985 as contained in Annex I to the present report based on the 2025 revised budget [that includes [US \$671,064] additional resources referred to in sub-paragraph (c) above]; and a 3 per cent increase in staff costs.

  - (ii) The Secretariat to send letters to the Governments of [Afghanistan, Angola, Botswana, Central African Republic, the Democratic People's Republic of Korea, the Democratic Republic of the Congo, Djibouti, Equatorial Guinea, Haiti, Sri Lanka and the United Republic of Tanzania] regarding the outstanding CP data reports for 2022, urging them to submit those reports as soon as possible.

- (c) To encourage NOUs to submit, on a yearly basis and in a timely manner, their assessments of the qualitative performance of the bilateral and implementing agencies in assisting their governments, noting that 80 out of the 144 countries had submitted such assessments for 2022, as compared to 75 in 2021; and

The Executive Committee may wish:

- (a) To note document UNEP/OzL.Pro/ExCom/93/96 on the draft guidelines for funding the phase-down of HFCs in Article 5 countries, including consideration of operationalizing paragraph 24 of decision XXVIII/2; and
- (b) To continue its deliberations on the guidelines for funding the phase-down of HFCs in Article 5 countries in light of document UNEP/OzL.Pro/ExCom/93/96.

<u>Document UNEP/OzL.Pro/ExCom/93/97</u> presents a paper on the starting point for sustained aggregate reductions based on the discussions that took place at the 91<sup>st</sup> and 92<sup>nd</sup> meetings in the contact group on the cost guidelines for the phase-down of HFCs (decision 91/64(a)).

#### Issues to be addressed:

#### The Executive Committee may wish:

- (b) To consider the information contained in the document referred to in subparagraph (a) above in the context of its discussions on the starting point for sustained aggregate reductions in HFC consumption.
- (b) Operational framework to further elaborate on institutional aspects and projects and activities that could be undertaken by the Multilateral Fund for maintaining and/or enhancing the energy efficiency of replacement technologies and equipment in the manufacturing and servicing sectors when phasing down HFCs: A report on decision 92/38(a)

<u>Document UNEP/OzL.Pro/ExCom/93/98</u> presents information requested by decision 92/38 containing (i) any additional activities to maintain and/or enhance energy efficiency while phasing down HFCs beyond those listed in paragraph (b)(i) of decision 91/65; (ii) information on additional costs and savings while implementing those activities taking into account the payback associated with the use of energy-efficient equipment and other benefits to the consumer; (iii) options for funding modalities in the Multilateral Fund (MLF) as well as possible implications of their operation; (iv) updated information on the role of other institutions addressing energy efficiency, where appropriate; and (v) a proposed methodology for monitoring and reporting on the progress of projects to maintain and/or enhance the energy efficiency of replacement equipment in the HFC phase-down, taking note of relevant methodologies, where appropriate (decision 92/38). The document contains three chapters, including the operational framework with MLF grant funding; the operational framework with blended finance from MLF and non-MLF resources; and a summary and recommendation.

Issues to be addressed:

• Consideration of a path forward for the operational framework for maintaining and/or enhancing energy efficiency of replacement technologies and equipment in the manufacturing and servicing sectors when phasing down HFCs.

#### The Executive Committee may wish:

- (a) To note the information provided in the report on operational framework to further elaborate on institutional aspects and projects and activities that could be undertaken by the Multilateral Fund for maintaining and/or enhancing the energy efficiency of replacement technologies and equipment in the manufacturing and servicing sectors when phasing down HFCs (decision 92/38(a)), contained in document UNEP/OzL.Pro/ExCom/93/98; and
- (b) To take into account the information provided in the report referred to in subparagraph (a) above, when considering a path forward for the operational framework for maintaining and/or enhancing energy efficiency of replacement technologies and equipment in the manufacturing and servicing sectors when phasing down HFCs.
- (c) Paper containing information on the types of activities that Article 5 countries could undertake, on the nature of the assistance required and on supply chain issues that needed to be resolved to address consumption in the local installation and assembly subsector in their Kigali HFC implementation plans (decision 92/39(c))

<u>Document UNEP/OzL.Pro/ExCom/93/99</u> presents information on the types of activities that Article 5 countries could undertake, on the nature of the assistance required and on supply-chain issues that needed to be resolved to address consumption in the local installation and assembly subsector in their KIPs.

# 11. Review of the administrative cost regime of the Multilateral Fund (decisions 88/74(c) and 91/67(b))

<u>Document UNEP/OzL.Pro/ExCom/93/101</u> presents an analysis of the administrative cost regime and core unit funding, taking into consideration relevant decisions by the Executive Committee, including those taken up to the meeting prior to the last meeting of 2023, on the basis of which the Committee would decide whether the administrative cost regime of the Multilateral Fund for the triennium 2021–2023 should be maintained for the triennium 2024–2026.

#### Issues to be addressed:

- Consideration of changes to the core unit funding for implementing agencies and the administrative cost regime for the Multilateral Fund
- Consideration of one-time funding for each bilateral and implementing agency, as lead or cooperating agency, for technical and policy assistance to each LVC country in the implementation of KIPs

- (a) To note the review of the administrative cost regime of the Multilateral Fund (decisions 88/74(c) and 91/67(b)), as contained in document UNEP/OzL.Pro/ExCom/93/101;
- (b) To consider:
  - (i) Increasing the core unit funding for UNDP, UNIDO and the World Bank, each by US \$200,000, for each year of the triennium 2024–2026, for strengthening their capacity to provide technical and policy support to Article 5 countries;
  - (ii) That the administrative cost regime for the Multilateral Fund for the triennium 2021–2023 would be maintained for the triennium 2024–2026, except for agency fees for stage I of Kigali HFC implementation plans (KIPs) for low-volume-consuming (LVC) countries, which will be applied starting 93<sup>rd</sup> meeting as follows:
    - a. At 13 per cent on projects up to a value of US \$500,000;

- b. At 13 per cent on the first US \$500,000 and 11 per cent on the balance on projects with a value exceeding US \$500,000;
- (iii) Outside the administrative cost regime for the Multilateral Fund for the triennium 2024–2026, providing one-time funding in the amount of US \$7,500 to each bilateral and implementing agency, as lead or cooperating agency, for its technical and policy assistance to each LVC country in the implementation of KIPs, on the understanding that:
  - a. The requests for funding should follow established practice including business planning and be included in the bilateral cooperation, work programmes or work programme amendments of the agencies and activities resulting from this funding shall be completed no later than 24 months from the date of approval;
  - b. Bilateral and implementing agencies will report on the technical and policy assistance activities provided to all countries and their impact as part of the narrative of their annual progress and financial reports; and
- (c) To review the administrative cost regime and its core unit funding budget at the last meeting of 2026, i.e., the last meeting of the 2024–2026 triennium, including the review of the implementation of subparagraph (b).

### 12. Overview of current monitoring, reporting, verification and enforceable licensing and quota systems developed with support from the Multilateral Fund (decision 91/68)

<u>Document UNEP/OzL.Pro/ExCom/93/102</u> was prepared in response to decision 91/68 and includes a note by the Secretariat, taking into account the discussions at its 89<sup>th</sup> and 91<sup>st</sup> meetings and the relevant discussions at the Thirty-Fourth Meeting of the Parties to the Montreal Protocol, 45<sup>th</sup> meeting of the OEWG, including the workshop on further strengthening the effective implementation and enforcement of the Montreal Protocol to be held in line with decision XXXIV/8, and the Thirty-Fifth Meeting of the Parties.

Issues to be addressed: None

The Executive Committee may wish to consider the matter.

### 13. Results framework and a scorecard that fit the operations of the Multilateral Fund (decision 92/41(b))

<u>Document UNEP/OzL.Pro/ExCom/93/103</u> presents a revised results framework and a scorecard based on the revised results framework for consideration by the Executive Committee.

Issues to be addressed:

• A results framework and scorecard proposed pursuant to decision 92/41(b) as contained in document UNEP/OzL.Pro/ExCom/93/103.

- (a) To note the results framework and scorecard that fit the operations of the Multilateral Fund (decision 92/41(b)), contained in document UNEP/OzL.Pro/ExCom/93/103;
- (b) To approve the results framework and scorecard presented in the document referred to in sub-paragraph (a) above; and

(c) To request the Secretariat to start the implementation of the first results framework from 2024, and to communicate progress in the implementation of this results framework through a scorecard at the second meeting of 2027.

#### 14. Report of the Sub-group on the Production Sector

<u>Document UNEP/OzL.Pro/ExCom/93/104</u>, to be issued during the 93<sup>rd</sup> meeting, will provide a report of the meeting of the Sub-group on the Production Sector that will take place on the margins of the meeting.

#### 16. Adoption of the report

The Executive Committee will have in front of it the draft report of the 93<sup>rd</sup> meeting for its consideration and adoption.
