

## Quick Start Programme status report, 22 January 2007

### Introduction:

1. The present report provides information on activities supported by the SAICM Quick Start Programme (QSP) since its establishment in 2006 with a view to facilitating coordination with the activities of other funding mechanisms, particularly the Global Environment Facility (GEF) and the Multilateral Fund (MLF) for the Implementation of the Montreal Protocol. The SAICM secretariat would be pleased to provide further details of QSP-supported projects to the secretariats of the GEF and MLF and their implementing and executing agencies. The SAICM secretariat also notes the potential for the QSP to be used as co-financing for projects under mechanisms such as the GEF and MLF.

### Background:

2. The International Conference on Chemicals Management (ICCM) decided in resolution I/4 to invite the United Nations Environment Programme (UNEP) to establish a voluntary, time-limited trust fund to provide seed money to support the objective and strategic priorities of the QSP. The objective of the QSP is to “support initial enabling capacity building and implementation activities in developing countries, least developed countries, small island developing States and countries with economies in transition”, including for the following strategic priorities:

- a) Development or updating of national chemical profiles and the identification of capacity needs for sound chemicals management;
- b) Development and strengthening of national chemicals management institutions, plans, programmes and activities to implement the Strategic Approach, building upon work conducted to implement international chemicals-related agreements and initiatives;
- c) Undertaking analysis, interagency coordination, and public participation activities directed at enabling the implementation of the Strategic Approach by integrating – i.e., mainstreaming – the sound management of chemicals in national strategies, and thereby informing development assistance cooperation priorities.

3. Governments of developing countries and countries with economies in transition are eligible for support through the QSP trust fund for project between \$50,000 and \$250,000, which are of a maximum duration of 24 months. Proposals may be presented by SAICM participating Governments that have given appropriate formal recognition to SAICM, at a minimum by having designated an official SAICM national focal point. On an exceptional basis, civil society networks participating in SAICM can also be eligible to present project proposals. Intergovernmental Organizations or Secretariats of Multilateral Environment Agreements may also be involved in projects, as executing agencies, or as sub-contractors<sup>1</sup>. The Trust Fund Implementation Committee will only approve one national Government project to be undertaken at a time, but it is possible for a Government also to participate in a multi-country or NGO project while undertaking the national project.

### Links with Overarching Policy Strategy Financial provisions:

4. The QSP and its trust fund were not intended by the ICCM to be a comprehensive financial mechanism to support the implementation of SAICM in developing countries and countries with economies in transition. Rather, the QSP is but one of six elements in the SAICM

financial arrangements set out in paragraph 19 of the Overarching Policy Strategy, which includes among other things:

“d) making more effective use of and building upon existing sources of relevant global funding, including by inviting the Global Environment Facility and the Montreal Protocol on Substances that Deplete the Ozone Layer and its Multilateral Fund for the Implementation of the Montreal Protocol within their mandates to consider whether and how they might support implementation of appropriate and relevant SAICM objectives and to report;...”

5. In its decision 24/3 II of 9 February 2007, UNEP Governing Council encouraged the SAICM secretariat to “explore ways to make more effective use of the funding provisions of the Overarching Policy Strategy... to identify those areas that can support implementation of appropriate and relevant objectives of SAICM.” In the QSP context, the secretariat interprets this request inter alia as a reiteration of the need utilize the QSP’s leveraging potential, for example by assisting in the development of projects that use QSP “seed money” to unlock more substantial sources of assistance, including the Global Environment Facility and the Multilateral Fund for the Implementation of the Montreal Protocol

6. In order to make the OPS provisions operational, the SAICM secretariat, through the UNEP Executive Director, has drawn this invitation to the attention of the GEF and MLF secretariats, inviting them to consider ways in which the GEF and MLF might be able to contribute to the QSP, for example if GEF or MLF projects supported the objective and strategic priorities of the QSP or projects could received QSP and GEF/MLF co-financing.

### **QSP trust fund projects and financial situation**

7. Over three rounds of applications to the Quick Start Programme (QSP) trust fund, held between May 2006 and September 2007, the secretariat received ninety project proposals. The QSP Trust Fund Implementation Committee<sup>2</sup> approved forty projects for a total funding of \$6,060,258. The projects will be implemented by forty-seven Governments and four civil society organizations and involve activities in fifty-one countries, including twenty Least Developed Countries and six Small Island Developing States. The annex to the present note provides tables (A to E) summarizing the projects approved so far.

8. For the year 2006, the secretariat received contributions from 15 donors totalling approximately \$5,968,000. As of December 2007, the secretariat had received pledges from 11 donors totalling approximately \$4,553,000.<sup>3</sup> The balance of funds available for the next application round closing on 7 March 2008 is therefore \$4,460,000.

9. In 2007, contributions to the non-trust fund QSP have also been declared by the Governments of Canada, Japan, Switzerland, Sweden and the United Kingdom, as well as by ICCA, OECD, UNDP, UNEP, UNIDO, UNITAR and WHO.<sup>4</sup> QSP Executive Board members<sup>5</sup>

reviewed the declaration forms and decided that all the declared contributions qualified as contributions to the QSP, as set out in table F in annex to the present note<sup>6</sup>. An additional declaration was made by the FAO in November 2007, which will be considered by the QSP Executive Board before its next meeting.

### **GEF and MLF contributions, co-financing and coordination with the QSP**

10. Many chemicals management activities already being undertaken with support from the GEF and MLF could be identified as contributions to SAICM implementation. In particular, the GEF and MLF secretariats may wish to consider declaring their chemicals management activities as contributions to the non-trust fund QSP referred to in paragraph 9 above. Such contributions, if confirmed as relevant by the QSP Executive Board, entitle the contributors to participate in the Board. Declaring the contributions will help provide a fuller picture of international efforts to promote the sound management of chemicals.

11. Notwithstanding the vastly greater financial resources managed by the GEF and MLF relative to those of the SAICM QSP trust fund, there may be mutual benefits in the co-financing of projects. Such partnerships would enable the QSP trust fund to fulfil its function of providing “seed money” to leverage more substantial resources. The availability of QSP trust fund resources of up to \$250,000 per project could assist GEF applicants in meeting the sometimes difficult prerequisite of co-financing for GEF projects. The QSP could contribute, in particular, to financing general chemicals management components of GEF and MLF projects. While important, such components may not be easily justifiable in terms of the specific funding criteria of, for example, individual GEF focal areas. The rapidity of the SAICM QSP trust fund process, with decisions taken by the Implementation Committee within six weeks of the closure of each application round, means that GEF and MLF applicants would be able to identify QSP co-financing with certainty while preparing GEF and MLF applications. The GEF secretariat has indicated its support, in principle, for the concept of using SAICM projects as co-financing for GEF projects and offered to encourage GEF implementing and executing agencies to pursue such co-financing opportunities.

12. The present report represents an effort by the SAICM secretariat to initiate liaison with the GEF and MLF secretariats and with their implementing and executing agencies to exchange information on proposed and approved projects and to facilitate reporting of chemicals management activities. The GEF secretariat has expressed its willingness to establish a process for consultation with the SAICM secretariat, including sharing of information on its “pipeline” of project proposals. There is also scope for SAICM coordination with GEF and MLF projects at the agency level since, with the exception of the World Bank, all GEF and MLF implementing agencies, i.e. UNEP, UNDP and UNIDO<sup>7</sup>, are members of the SAICM QSP Trust Fund Implementation Committee.<sup>8</sup> In addition, FAO, a GEF “executing agency with expanded opportunities” is also a member of the Committee. In order to avoid duplication and promote complementarity, the Implementation Committee already pays particular attention to other relevant multilateral and bilateral projects when considering applications to the QSP Trust Fund. The effectiveness of this review process could be enhanced through the more systematic exchange of information on current and pending projects amongst the SAICM, GEF and MLF secretariats.
