拖延项目的执行情况以及第5条国家实现遵守
《蒙特利尔议定书》今后管制措施的前景

印发本文件是为了：

- 以下文取代执行摘要的第二个圆点项目符：
 - 由8个国家报告的2008年数据表明，可能存在对氟氯化碳管制措施（孟加拉国、波斯尼亚和黑塞哥维那、多米尼加共和国¹、密克罗尼西亚联邦、伊拉克共和国、沙特阿拉伯、瓦努阿图和委内瑞拉玻利瓦尔共和国）；哈龙（伊拉克和瓦努阿图）；甲基溴（伊拉克和瓦努阿图）；以及，四氯化碳管制措施（玻利维亚、厄瓜多尔、印度尼西亚、伊拉克、墨西哥和土库曼斯坦）。
- 在 UNEP/OzL.Pro/ExCom/58/6 号文件的始终，针对阿根廷，以 902.3 ODP 吨取代 50.8 ODP 吨的 2008 年各类氟氯化碳消费数据，以 221.1 ODP 吨取代 22.5 ODP 吨的 2008 年甲基溴消费数据。
